KNACK will promote cooperation and innovation among European higher education institutions, associations and businesspeople and more broadly in society to foster development of Sustainable Smart Cities (SPACE). KNACK proposes a collaborative approach on current urban needs to overcome existing inadequacies of university courses, curricula and syllabuses.

Thus KNACK MOOC modules are targeted to upgrade the built environment programme curricula. The intent is to include teamwork with non-academic partners by learning from cities with demonstrated SPACE strong points that have disseminated such awareness to other countries. It will also contribute to innovative, multidisciplinary, learner-centred and real problem-based teaching and learning approaches. Innovative teaching methods with cooperating business partners, associations and public institutions will enhance the entrepreneurial skills and attitudes of teachers and students and facilitate knowledge exchanges between academia, business and society.

The main output results are as follows:

- 1) Twelve new MOOC modules aimed at unlimited participation will be developed and integrated with existing BSc, MSc and PhD programmes.
- 2) Innovative, multidisciplinary and personalized approaches and an Intelligent Cross-Institutional Affective Educational Centre (Data and Text Mining System, Recommender System, Simulators, Facial affect detection subsystem, Affective Tutoring System and Open Educational Resources) will be developed.
- 3) The new modules will be available for one-academic year studies for 380 students in class and 210 students virtually. There will be 38 PhD students participating in the pilot project. This project also provides, over its course, virtual training for 28 teachers and 42 practitioners.

KNACK System selects educational materials of utmost benefit by considering learning materials, a student's history of learning and his/her valence, arousal and emotional state, the Yerkes–Dodson Law, etc.
